Photography and Images of Children - Withdrawal of Consent Form

Dear Parent or Carer

During your child's life at 1st Wellesbourne Beavers, Cubs or Scouts we may take photographs of activities that involve your child. Those photographs may be used by us for displays, publications and on our website and they could also be used by the Scout Association, by local newspapers or occasionally even by national newspapers.

Examples of where photographs may be used include:

- Scout Group personnel may take photographs of Beavers, Cubs or Scouts which may feature in setting up displays to show the life of 1st Wellesbourne Scout Group
- The local media may take images of activities that show 1st Wellesbourne Scout Group and individual Beavers, Cubs or Scouts in a positive light e.g. Investitures, performances, activities and prize giving
- Photographers acting on behalf of the Scout Group may take images for use in displays, in Scout Association publications or on a website
- Images may occasionally be used for publicity or campaigns by the national Scout Association

The 1st Wellesbourne Scout Group policy is:

- Photography or filming will only take place with the permission of the Group Scout Leader, and under appropriate supervision
- Children will only be named if there is a particular reason to do so (e.g. they have won a prize), and home addresses will never be given
- Images that might cause embarrassment or distress will not be used nor will images be associated with material on issues that are sensitive
- We will regularly review and delete unwanted material

So that we can recognise your wishes, please let us know using this form if you **do not** agree that photographs of your child may be used.

If you do not agree that photographs of your child may be used, please sign and date this form and return it to your section Leader.

If you agree that photographs of your child may be used, you do not need to do anything.

Please ask us if you want see images of your child held by 1st Wellesbourne Scout Group. You always have the option to review your decision on use of photographs and we will ask you from time to time.

Thank you; if you have any queries please ask your Beaver, Cub or Scout Leader.

Notes:

- Your child may feature in photographs of group activities such as parades, whole Group photographs etc, in this case we may not be able to remove your child entirely from the image but will ensure that your child does not feature prominently in such images
- If you wish to attend Scout Association functions and take photographs of your own and other people's children please take appropriate images, be sensitive to other people and try not to interrupt or disrupt activities and events.
- Occasionally your child will participate in events that are held in public. During these events it is likely that photographs will be taken by members of the public or organisations other than the 1st Wellesbourne Scout Group. You will appreciate that we cannot control how such public event photographs are used.
